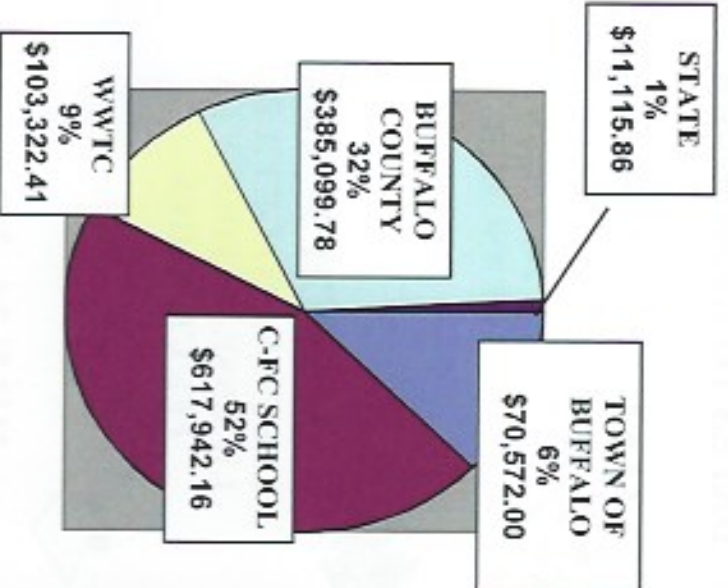

DO YOU HAVE A LOTTERY CREDIT ON YOUR TAX BILL?

To qualify:

1. You must own a home in Wisconsin, and
2. You must have occupied that home as your primary residence as of January 1st of the year in which the tax is levied (2015).
A primary residence is:
 - a. The home in which a property owner lives for more than 6 months a year
 - b. The address you use to file Wisconsin Income Tax
 - c. Listed on your driver's license
