

RESOLUTION TO INITIATE PROCESS FOR ALTERING A HIGHWAY

The Town Board of the Town of Buffalo, Buffalo County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

The process under chapter 82, Wis. stats. to lay out, alter or discontinue a highway in the town described as follows is hereby initiated:


That highway designated as Old State Road 35 beginning at entrance from State Highway 35/54 and extending East to a point of dead end at Thompson Bridge, a distance of approximately 859 feet or .16 miles and lying in Government Lot 1, NW 1/4 of the NW 1/4, Section 36, Township 19N, Range 11W

By this resolution, if application is approved, the Town of Buffalo will alter the above described highway by re-designating the name from Old Hwy 35 to Burt Lane. Signage and addresses will be changed to comply with the altered name, Burt Lane.

A scale map of the land that will be affected by this application is attached.
