

REGULAR MEETING, TUESDAY, APRIL 23, 2024 7:00 P.M.-TOWN HALL

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Waters, Bittner, Strom. Absent: Drazkowski. Citizens: Dan Rolbiecki, Jerome Gardner, Bob Baures, Gordy Albrecht, Jim Burfeind, Joyce Camerer, Doug Wolfe, Pau Barrett, Dan Wolf. The meeting was held as noticed. Motion Waters, second James to approve minutes from March 26, 2024 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of April 3, 2024: \$77,376.06. Balance as of April 23, 2024: \$54,649.91. Transportation Aid was received of \$19,055.98. CAPX to be received in May of \$71,788 Financial Statement reviewed. Bills were read. Motion Waters, second James to accept treasurer's report and pay bills. All yes, motion carried.

Chair: Broadband grant was approved. CCT has take over. Engineers have started. Will work until the snow flies. There will be two public forums in late May early June and will be combined with Fountain City. Jennifer Monsos is in charge of the Farmers Market. Eight vendors have been verified. It will be held Thursday evenings from 4-7 pm. Has talked with insurance for the ok. Chiropractor to expand building. Construction has started. Hoping to be done in June/July. They will need to vacate the building at times. Have discussed about using the Town Hall during the week for business. Open Book to be held June 4, 2024 from 3:00-6:00pm. Board of Review will be held June 11, 2024 from 6:00-8:00pm. Notice of Non-Compliance was received from Buffalo County for W364A Bluff Siding Road for junk/salvage material being stored. Four zoning permits received in 1st quarter. ATV/UTV ordinance added hours of usage on County Roads 5:00am-10:00pm. Suggest Towns to add also. Table to next meeting when all officers are present. WTA talked about new license ID cameras to place in key areas to hep with investigations in the Sheriffs Office. Areas in suggestion are Trempealeau-Buffalo County border; Buffalo Township-Fountain City border; Winona to place at end and beginning of bridge. Camera device cost \$3000 each. Information is saved for 30 days. Roaf Tour to be help April 30, 2024 at 1:00pm with someone from Buffalo County.

1st Supervisor: Town Hall Rental: 3 rentals in April; 4 rentals in May. Need help with cleaning Town Hall. Working with Zach Czaplewski to open restrooms in the park and installing drinking fountain in the park. Need a new sign for Recycling Center. Appliance drop of during regular hours.

2nd Supervisor: Road maintenance: Not present.

Clerk: Personal Property Tax bills that are delinquent have been sent out. Elections: August 13, November 5. Audit has started. Will be all online. CT form due May 15, 2024.

Went over the wording for the signs in the park. Keep it clean and simple with an insert. Will turn in for reimbursement with grant application.

There is concern for accidents happening where the Memorial has been placed on County Road M. People are standing in the roadway and might get hit. County Road and Township can not do anything about it. Very concerned for the safety of people stopping.
