

REGULAR MEETING, TUESDAY, APRIL 27, 2021 7:00 P.M.-TOWN HALL

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Waters, Drazkowski, Strom, Bittner. Citizens: Bob Baures, Jerome Gardner, Betty Buswell, Gordon Albrecht, Dan Rolbiecki. The meeting was held as noticed. Motion Waters, second Drazkowski to approve minutes from March 23, 2021 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance as of April 27, 2021 \$43,358.51. Delinquent Personal Property Taxes \$715.74 still owed. Postponed Personal Property Taxes \$259.91 due in July. Refugee received \$6456. CAPX \$78,000 in May. Transportation Aid \$18,3561.58 received. Financial Statement was read. Bills were read. Motion Drazkowski, second Waters to accept treasurer's report and pay bills. All yes, motion carried.

Chair: Motion Waters, second Drazkowski to appoint Lisa Braaten as the 2021-2023 Town Clerk/Treasurer. All yes, motion carried. Motion Drazkowski, second Waters to accept the Road Maintenance agreement for May 1, 2021 through April 30, 2024 with Baures Excavating with the exception of hiring out the cutting down of larger trees. All yes, motion carried. New Addresses: Cell tower-W220 Chicken Valley Road; Cell tower-W221 Chicken Valley Road; Poultry Barn 125 Sharmota Lane; Cabin- W125A Sharmota Lane. Comprehensive Lane Use Plan Committee will meet May 11, 2021 at 630 pm. Motion Waters, second Drazkowski to move Open Book and Board of Review to May 25, 2021 at 645 pm. All yes, motion carried. Meetings will be rescheduled/postponed to September 14 and 21, 2021 when the re-assessment has been completed. Hazardous Mitigation Plan is a 5-year project. American Rescue Plan is in play and Town will receive monies in 2 different payments from the Federal Government. Discussion of Recognition in honor of Dennis Semling to mount a deer and place in the Town Hall with a plaque. Two non-compliance Zoning issues. First William Isaskson has property with more than one non licensed vehicle. Needs to comply by May 29, 2021. Second Paul Barrett final notice needs to comply by July 9, 2021 has more than one non licensed vehicle on property.

1st Supervisor: Town Hall Rental: 2 rentals in April. Cemetery meeting was held April 11, 2021. Purchased Town Hall supplies. Need to clean and wash windows. Park Restrooms will be open May 15 or later.

2nd Supervisor: Baures' bill was gone over. Grading, brushing, tree removal, Brandhorst. Discussion of reconstruction Brandhorst Road. Need culvert extension by Bittners on Piepers Valley Road. Pot holes need to be patched. Major hole on Oak Lane.

Baures spoke on behalf of his relationship with Dennis. Baures offered to help out as much as he possibly can.
