

REGULAR MEETING, TUESDAY, August 23, 2022 7:00 P.M.-TOWN HALL

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Drazkowski, Waters, Bittner, Strom. Citizens: Bob Baures, Jerome Gardner, Gordon Albrecht. The meeting was held as noticed. Motion Waters, second Drazkowski to approve minutes with changes from July 26, 2022 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of August 3, 2022: \$50,628.34. Balance as of August 23, 2022: \$32,043.14. Received: August Settlement of \$26,915.26. Financial Statement gone over. Bills were read. Motion Drazkowski, second Waters to accept treasurer's report and pay bills. All yes, motion carried.

Chair: New address: S3596 Silver Street (Milton Stuber's old place). Broadband update: ranked 75. Awarded grants up to 71. CTC informed Board that there are funds that might be available. Some that were awarded did not accept. Approximately 200 addresses do not have surveys done. Will go door to door to get the information. Working on a new application for the next round. Buffalo County joint projects date of submission has been changed to September 15, 2022. Motion Drazkowski, second Waters to approve joint list to the County. All yes, motion carried. Waiting for land survey to be done by Kleinschmidt on Silver Street for the turn around. Scharlau is willing to split cost and would like the turn around to be stacked out. Zoning Violation on Amann Lane. Polston laid rip rap down and was not approved by the County. County is dealing with it. Parking Ordinance Violation letter was sent by certified mail on August 2, 2022 to residence with not return notice it was received. Drafting 2nd notice by regular mail. Parking Ordinance Permit to James for gathering at his residence. Possible parking in the road. Need to create a sign for the Park about Fireworks. "NO FIREWORKS ALLOWED" Motion Waters, second Drazkowski to order sign. All yes, motion carried. Looking into a gov email for the Town.

1st Supervisor: Town Hall Rental: 5 rentals in August; 4 rentals in September. One Park rental. Carpet to be cleaned in October. Looking for volunteers to help clean windows. Some electrical outlets do not work in the kitchen. Electrician needs to come in and redo for safety reasons. Looking for stronger weed killer for the park playground area. Bleachers need to be stained. Recycling Center is accepting batteries for a charge. Clean sweep will be held in May or June of 2023.

2nd Supervisor: Baures' bill was gone over. Bob Platter at the County has been notified of problem with culvert on County Road P. Gravel is non existing on Sutter Lane and causing mud. Need to replace and send bill to Wozney. Breezy Point residence appreciated the graded road. Maps and Documents need to be updated.

Clerk: General Election to be held November 8, 2022. Motion Waters, second Drazkowski to accept operator's license. All yes, motion carried. Budget prep is set for September 13, 2022 at 4:30 pm.
