The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Drazkowski, Waters, Bittner, Strom. Citizens: Dan Rolbiecki, Jerome Gardner, Gordon Albrecht, Bob Baures, Steve Scharlau, Joyce Camerer. The meeting was held as noticed. Motion Waters, second Drazkowski to approve minutes from May 23, 2023 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of June 3, 2023 is \$48,765.68. As of June 27, 2023 balance is \$55,059.78. Refuge was received June 20, 2023 of \$7,164.00. Transportation Aid in July of \$19,096.99. Financial Statement gone over. Bank statement for regular checking account was not received. Bills were read. Motion Drazkowski, second Waters to accept treasurer's report and pay bills. All yes, motion carried.

Chair: Snake population is increasing. Please be aware. DNR said a hose with cold water will chase them away. There was a report of a couple that was pulled over by the Buffalo County Sheriff's which ended up in weapons and drug arrest. Discussion of the Infrastructure. Shared Revenue and Transportation Aid to increase in 2024 and 2025. Terry moved pug ins in the kitchen. No filers for Board of Review. There were a couple adjustments. Silver Street is now an official road in Town of Buffalo, Buffalo County. Everything has been filled with the Register of Deeds. Sugar Maple was questioned if it is an official road, which it is. Steve Scharlau emailed Chair about a tree in the middle of the cul-de-sac on Sugar Maple Road. He is requesting the Town to replace when the existing maple tree needs to be removed. Discussion. TOB will not remove tree and will not act on this. Broadband grand application has been denied Federal has \$1 billion funds available. CCT will put a new application together. Will hear in July-August to the requirements for this round of applications. Park water was tested twice. Treatment was done. Still showing discoloration. Having Zach retreat and retest again July 6, 2023. Discussion of Park recognition/remembrance plague. The 1st recording was in April 1986 by Larry Sutton. 1987 committee was formed for the park and ballfield. TOB gave money to committee to build ballfield. 1991 land from Dairyland was deeded over to the TOB.

1st Supervisor: Town Hall Rental: 2 rentals in May, 9 rentals in June. There was a snake in the building. Motion Waters, second Drazkowski to sign contract for propane at \$1.749/gallon 600 gallons. All yes, motion carried. Park ballfield cost \$8500. Rest rooms look good. Bleachers need to be painted. Clean sweep 2025 will have a white barrel. Rate per person in 2024 is \$3. Drop off of tire will be a charge of \$20 per tire.

2nd Supervisor: Baures bill was gone over. Sutter Lane ditch work is done. Wozney will do the other side. Rocky Ridge needs a new culvert, reviewed Brandhorst, Gold Street needs patching, Chicken Valley needs new 24' culvert. Permit ok by DNR to clean Midway Road culvert. Huge hole on top oof Piepers Valley. Dying Trees on Thomas Road need to be sprayed on right of way. Tree roots on Castle Rock Road might be causing harm to culverts.

Clerk: Motion Waters, second James to accept Class B Liquor License for Dam Saloon, Midway, George's, Bluff Siding Social Club, 4-Mile and Hillside. All yes, motion carried. Motion Waters, second Drazkowski to accept Class A Liquor License for Wine House. All yes, motion carried. Motion Drazkowski, second Waters to accept all Operator's Licenses'. All yes, motion carried. Mary's Moe's was turned down until proper documentation is turned in. Will reevaluate at July meeting.

Dan Rolbiecki announced Dennis Semling's deer head with dedication plate is ready to hang.
