

**REGULAR MEETING, TUESDAY, MARCH 28TH, 201677:00 P.M.-TOWN HALL**

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Semling, Waters, Wantoch. Citizens: Don Bittner, Bob Baures, Judy Morgan, Gordie Albrecht, Dee Strom. The meeting was held as noticed. Motion Semling, second James to approve minutes from February 28, 2017 Regular Meeting with corrections adding Judy Morgan and Steve Berger. All yes, motion carried.

**Treasurer's Report:** Balance as of March 28 is \$74,790.93. CAPX will be received between April and May for \$72000. Delinquent Taxes for 2015 is \$11, 230.12. 2016 we have 17 parcels outstanding \$3192.27. Dogs, \$305, PPT \$517.78. Bills were read. Fund balance was gone over. Motion Semling, second Waters to accept treasurer's report and pay bills. All yes, motion carried.

**Chair:** Annual Meeting will be held April 18, 2017 at 7:00pm. Road Report will be presented at that time. The hit and run in the parking lot is being investigated by the County Sheriffs still. Everything has been fixed and blacktop will need to be added around the pole. WI Independent Assessors Association was discussed. Motion Semling, second Waters to pay \$100 to support them. All yes, motion carried. Motion Waters, second Semling to keep Clerk/Treasurer position as one and present recommendations at the annual meeting. All yes, motion carried. Deputy Clerk will have to be changed also to Deputy Clerk/Treasurer. Motion Waters, second Semling to present recommendations at the annual meeting. All yes, motion carried. Barth Mine has outstanding delinquent taxes from 2015. Assessor has been involved. Motion Waters, second Semling to contact attorney Mr. Kostner to put together a letter to attempt to collect the debt or Barth Mine will be shut down. All yes, motion carried. Park Water needs to be turned on. Schaffner's will be contacted. Towns Officials Workshop will be held May 2, 2017 in Tomah. Chair request that he is able to attend and cost is \$65.

Fire number is needed for Town Hall and Park per Buffalo County Zoning. Number is W387.
