The meeting was held as noticed. Motion Waters, second Drazkowski to approve minutes from April 25, 2021 Regular Meeting. All yes, motion carried.

**Treasurer's Report:** Balance as of May 25, 2021 \$71,785.01. CAPX was received of \$71,788.00. Property Aid received of \$424.37. Personal Property received of \$259.49, Delinquent \$463.83 and Postponed of \$259.91 still owed. Transportation Aid will be received in July. Financial Statement was read. Bills were read. Motion Waters, second Drazkowski to accept treasurer's report and pay bills. All yes, motion carried.

Half of \$68000 to be received as early as May. Discussion of roads for ATV/UTV to be used: Brandhorst, Pieper's Valley, Chicken Valley, Cole Bluff, Platte's Valley, Buffalo Ridge Road, Bluff Siding Road. Signage is needed on approved roads. New ordinance to eliminate Chicken Valley Road and Buffalo Ridge Road. New addresses: W359 Giraffe Trail for new home, and 355 Giraffe Road for change of address. Water testing not done yet by the County. Recycle notice for Clean Sweep on June 12, 2021 in Alma at the Highway Department. Comprehensive Planning Committee meeting to be held July 13, 2021 at 630pm.
