

SPECIAL MEETING, WEDNESDAY, SEPTEMBER 1, 2021 6:30 P.M.-TOWN HALL

The Special meeting of the Town of Buffalo was called to order by Chairman Steve James. Roll call: Waters, Draskowski, Strom. Absent: Bittner. Citizens: Bob Baures, Ken Bork, Jerome Gardner, Lee Gossin, Mike Bork, Kevin Buswell, Tim Ernst, Dick Bork, Dan Rolbiecki, Joe Duellman, Cindy and Doug Wolfe, Tony Krzoska. The meeting was held as noticed.

Brandhorst Road: Ernst site-culvert by corner is needed, engineer to size it, 4 foot is there now and not big enough, put off starting project until engineer comes in, above culvert placement can be ditched up to the culvert. Buswell site- rocks flowing into field, cement over rocks by culvert, hole needs filling, place larger culvert, 48" tube.

Pieper's Valley: George site needs engineer to look at, 5-foot culvert is not big enough, increase to 8-foot culvert, barrel needs to be removed and placed at Recycling Center. Culvert down from George's sit need cleaning before Katula's place. Wolfe's culvert needs rocks removed and to add cement. Lyga culvert is ok. Mow banks of brush by Wolfes.

Midway/Sikorski: Something blocking creek. County Engineered bridge project. Check with County.

Jumbeck: Needs gravel, rip rap and pole replaced.

Chicken Valley: removal of trees once identified.

Oak Lane: .21 miles of road work costing \$6000 to be postponed.

Bork Lane: double chip seal 1.06 miles costing \$46,800.

Silver Street: turn around needed for snowplowing. Question where road ends and right away is. Kleinschmidt survey 50/50 with Scharlau. Barr's has a pothole.

Hoesley Lane: pothole by Jordan Hoesley, Lynn and Allen Hoelsey did grading.

Rocky Ridge: ditches have been done, need to plant grass seed, culvert below Bronks-4-foot culvert or tube before Bronk's driveway, gravel done, steel culverts all too small, need bigger.

Spur Lane; Town road and right away undecided, County helping, parking will be taken care of with Parking Ordinance.

Bluff siding Road: Bridge needs to be replaced; DOT assessment received. 50/50 joint project with County. Ditching needed by Alliance Bank.

Platte's Valley-nothing

Gold Street: tree issues, need to be remove, right away issue, County to look into.

Buffalo Ridge Lane: culvert plugged, needs cleaning out, one end is out of ground.

Veraguth Drive: Nothing

Sutter Lane: Nothing
