Motion Waters, second James to approve minutes from March 29, 2022 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of April 3, 2022: \$5, 850.40. Balance as of April 26, 2022: \$18404.42. Transportation Aid received of \$18,726.78. CAPX will be received in May of \$71,788. Liquor Licenses are due in June. Financial Statement gone over. Bills were read. Motion Waters, second Drazkowski to accept treasurer's report and pay bills. All yes, motion carried.

Chair: Announcements: Michael Owecke passed away unexpectedly. Mr. Owecke worked in the Zoning Department at the County. Condolences sent to the family. Flag has been destroyed by wind. Working on replacing it. Open Book is scheduled for June 7, 2022 from 3:00 pm- 6:00 pm. Board of Review is scheduled for June 14, 2022 from 6:00 pm-8:00 pm. Annual meeting will be held April 18, 2023 at 7:00 pm. Audit Completed. Contract renewal is \$3650. ARPA report date is April 30, 2022. Broadband grant application was submitted. Expect to hear back in late June early July. Next meeting is set for Jun 21, 2022 at 6:30 pm. Town of Buffalo was the only one from Buffalo County that turned in application. Total of 194 applications were sent in. Brush has been removed/cleared for Flyway Bike Trail. The crossing by the railroad has not been officially approved yet. 2.5 million donations were received to help cover the cost to finish. Parking Ordinance violations is an on-going issue on Spur Lane. Motion Waters, second Drazkowski to approve letter to be sent to residents informing them the Town will take aggressive action for violations. All yes, motion carried. Thomas Road has been cleaned up and a check received in full. Motion Waters, second Drazkowski to approve a yield to in coming traffic sign to be placed at the intersection by George's, Alliance Bank and traffic from Highway. All yes, motion carried. Buffalo County joint projects: Brandhorst, Piper's Valley and Chicken Valley. Discussion of Bridge by Mary Moe's on Bluff Siding Road. Rating of .56 to decrease below .5 to receive Federal help. Patch potholes and fix railing for now. Gold Street culvert project we still owe a small amount. Midway project there was an over payment. County to use overpayment to cover amount owed.

1st Supervisor: Town Hall Rental: 7 rentals in April, 6 in May. Discussion of charging \$125 for residents and \$150 for nonresidents. Water testing to be done by Schaffner's. Stamps to go up to \$.60. Picking up several rolls. Riverland Energy will be collecting appliances in Arcadia. Buffalo County census went down. Rest rooms in park will be opened by Schaffner's. Need some volunteers to help fix the ball field. Discussion at the WTA meeting to adopt a resolution of the MFL Program and sent to the Senators, Congress, etc. A copy of Buffalo County resolution can be used by the Town.

2nd **Supervisor:** Baures' bill was gone over. Pathing on the bridge. Bluff Siding Road speed bumps shaved down. Culvert put in on Brandhorst by Tim Ernst place.

Clerk: Audit finished up with report. Liquor Licenses to be sent out. Next election to be held August 9th Partisan primary.
