

REGULAR MEETING, TUESDAY, JULY 23, 2024 7:00 P.M.-TOWN HALL

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Waters, Drazkowski, Strom, Bittner. Motion Waters, second James to approve minutes from June 25, 2024 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of July 3, 2024: \$69,486.69. Balance as of July 23, 2024: \$83,347.82. Transportation Aid was received of \$19,096.98. Shared Revenue was received of \$11,773.58. Computer Aid was received of \$202.66. Fire dues was received of \$3253.43. Financial Statement reviewed. Bills were read. Motion Waters, second James to accept treasurer's report and pay bills. All yes, motion carried.

Chair: New Address for Jeff and Roxanne Guenther of S3528 Grawe Lane. Board met with CCT about a cable issue for Broadband. Farmer's Market is held Thursday evenings. Seven vendors with a few more coming with produce. Nice flow of people. Right away resolution was presented to the Board. Discussion. Explains in detail of right away and the encroachment onto the right away. Resolution was read to the public. No grandfathering in. Everyone needs to follow. Adoption of resolution at August meeting. Dan Picha spoke about stopping erosion in their yard. Flowers that they have planted were mowed over. Culvert in plugged and needs to be cleaned out. Discussion. Recommend to mow vegetation on Town roads. ATV access permit: put together 3 years ago by County. County to revisit map in 2025. Can amend to add a small stretch of road from Grawe Lane to Chicken Valley Road to Bluff Siding Road. Suggest to talk with Sheriff since the map was developed with the Sheriff. Will table to August meeting after discussion with Sheriff. Town Web upgrade will cost \$1700. Spoke with Jeff Strom ideals of putting website together ourselves. To discuss with further. Discussion of vehicle ID cameras to be too expensive for Town for a 10-year contract. SAM renewal was done. Everything to be in line with broadband and Federal program. Active until 11/13/25. Fire Association to meet 7/24/24 at 7:00pm at the fire station. New tanker was ordered.

1st Supervisor: Town Hall Rental: 6 rentals in July. 2 park rentals. Septic tanks have all been pumped. Alarm was going off for the septic tank. Recycling Director for County has not been announced yet. Brush from storm was hauled to recycling center.

2nd Supervisor: Baures bill gone over. Century 21 was informed that house on Lipinski Ln will have to share culvert replacement and retaining wall needs to be fixed. Leaning trees after storm on Thomas Road. Brush to be cleaned up. Trees leaning by Scharlau. He will be responsible if they fall.

Clerk: Personal Property Taxes: 1 delinquent and 1 postponed. Elections for 2024 are August 13, 2024 and November 5, 2024. Public Testing to be held August 4, 2024 at 6:00pm. Sign Auditor Management letter.

Next Regular meeting to be held August 27, 2024 at 7:00 pm.

Motion Waters, second Draskowski to adjourn the meeting. All yes, motion carried. Meeting was adjourned at 8:15 pm.
