

REGULAR MEETING, TUESDAY, FEBRUARY 22, 2022 7:00 P.M.-TOWN HALL

The Regular meeting of the Town of Buffalo Board was called to order by Chairman Steve James. Roll call: Drazkowski, Bittner, Strom. Phone: Waters. Citizens: Dan Rolbiecki, Jeff Strom, Gordon Albrecht, Steve Berger, Deb Anderson, Lorraine Baures. The meeting was held as noticed. Motion Drazkowski, second James to approve minutes from January 25, 2022 Regular Meeting. All yes, motion carried.

Treasurer's Report: Balance of February 3, 2022: \$570,394.59. Balance as of February 22: \$675,537.32. Real Estate collected in taxes: \$805,018.07; PPT: \$12,056.14: Delinquent Real Estate: \$61,663.62: Delinquent PPT: \$1,722.89. Financial Statement gone over. Bills were read. Motion Waters, second Drazkowski to accept treasurer's report and pay bills. All yes, motion carried.

Chair: Bluff Siding Sign was placed on Hwy 35 again. Motion Waters, second Drazkowski to transfer \$16,088 from ARPA account to checking for Fire Association Fire Run invoice. All yes, motion carried. Suggested to repay funds borrowed from CAPX. Steve Berger from Rural Mutual went over the insurance policy. Broadband Project: PPP has been signed, CCT is in charge, County has informed Town they are willing to contribute \$100,000 towards Broadband installation, Working on Grant money which is due March 14, 2022, Committee is going around asking for support from businesses and farmers. Department of Revenue received 2 appeals from the Board of Review. Only one was heard. Received letter that Town is in compliance with the State Property Assessment. FEMA approved remainder of administration fees of \$6,167.45. Should receive in about 2 weeks. District meeting workshop will be held on March 4, 2022 in LaCrosse, WI. Topics of interest are Certification for BOR, ARPA Funding, Infrastructure bill. Motion Waters, second Drazkowski to approve Chair James to attend and Town to pay for registration. All yes, motion carried.

1st Supervisor: Town Hall Rental: 1 rental in March, 3 rentals in April, 1 rental in June.

2nd Supervisor: Baures' bill was gone over. Parking ticket warnings have been issued. Spur Lane is still and issue.

Clerk: Audit is in progress. Motion Drazkowski, second Waters to allow Clerk to approve delinquent taxes less than \$5 to change to postpone and add to 2nd half. All yes, motion carried.

Dan Rolbecki presented the deer head mount in honor of Dennis Semling. Motion Drazkowski, second Waters to cover material cost of \$175 that were used for the mount. All yes, motion carried.


